Master of International Development Policy

MIDP is a practitioner-oriented program for mid-career professionals. Both one- and two-year degree programs are offered. Graduates of the program find work in government ministries, international finance agencies, NGOs and the private sector.

International Taxation Program

The International Taxation Program is designed to develop the analytical skills in economics, law and administration needed to create and implement successful tax reforms throughout the world. The program focuses on three key areas of taxation: policy, administration and legislation.

Public Financial Management Program

The Public Financial Management Program is designed to enable international development decision makers and managers to improve public sector budgeting and financial management and enhance the efficient, accountable and equitable delivery of public services.

Duke-UNC Rotary Peace Center

MIDP Rotary Peace Fellows receive funding toward their studies in democracy building, sustainable development and conflict prevention, with a focus on international development. This joint program is hosted by Duke University and the University of North Carolina at Chapel Hill.



Executive Education

Each year, policy professionals from around the world participate in short-term DCID programs in their countries and at Duke.

Custom Programs

These programs are offered for governments and agencies seeking training directly related to their regional and professional needs. Faculty members draw on their global practical experience to train officials from countries around the world. Recent examples include China, India and Kazakhstan. Customization can include:

- **Content** Materials are adapted based on the needs and professional experience of the participants.
- **Location** Programs can take place at Duke, in the country of the participants, or a combination of both.
- **Duration** Program length can range from one week to a full academic semester.

Policy Advising

DCID faculty are engaged around the world in advising services with government ministries, international agencies and NGOs. Advising initiatives enable DCID to put knowledge in the service of society and garner experience applicable to classroom training. Areas of expertise include:
