

CONCURRENT 15-CREDIT GRADUATE CERTIFICATE IN INTERNATIONAL DEVELOPMENT POLICY (IDP)

For those who entered Duke in Fall, 2020 or after

The Master of International Development Policy (MIDP) Program offers a 15-Credit Certificate in International Development Policy (IDP) to students who enrolled in full time graduate and professional programs at Duke in Fall, 2020 or after. To earn the certificate, the following course requirements must be fulfilled prior to graduation from the degree program.

REQUIREMENTS

A total of 15 credits (a minimum of 9 credits must be MIDP courses*) is required for completion of the certificate, which includes:

- An International Development Economics course (3 credits)
- International Development Electives (12 credits)

**MIDP courses are usually PUBPOL courses numbered 700s. One 3-credit PUBPOL course (numbered 500s, 600s or 800s) on the list below may be substituted for one of the MIDP courses.*

PROCESS

- 1) APPLY:** The [15-Credit IDP Certificate Application](#) is required for admission, and applications are accepted on a rolling basis. Applicants will be admitted in October and March of each year, prior to course registration.
Note: Students enrolled in the Graduate School (one of Duke's Schools) must also complete the [Graduate Certificate Program Application](#) as required by their home department, and upload it to the [15-Credit IDP Certificate Application](#).
 - Students may begin taking courses toward completion of the certificate before they are officially enrolled.
 - By submitting an application, students are formally accepting that the certificate will be added to their records.
 - The applicant will be notified by MIDP only if the application has not been approved.
 - ***Once the certificate has been added to the academic record it cannot be removed.*** Should the student fail to complete the requirements by the end of their graduation term, the certificate will appear as 'discontinued' on their academic record.
- 2) COMPLETE:** To confirm the fulfillment of the requirements, submission of the [IDP Certificate Completion Form](#) is required. Graduate School students must also complete and submit the [Graduate Certificate Program Application](#) as required by their home department. The deadline to submit this completion form and have the IDP Certificate added to a record for Fall graduates is **October 1** of their final semester. The deadline to submit for Spring graduates is **March 1** of their final semester.
 - Students who have completed the requirements without being officially enrolled in the certificate may have it added to their academic record in their final semester of study.
 - In addition to the certificate requirements, students must successfully complete their concurrent primary graduate degree. Failure to earn the primary degree will automatically result in the certificate being "discontinued."
 - Confirmation of the certificate will be sent to students who have successfully completed all the certificate requirements. The confirmation will occur in the final semester of their primary degree. The certificate appears on the transcript.

APPROVED COURSES:

For a class to be counted towards the certificate, the content must focus on international development. If you have questions or are interested in counting a class that is not listed below towards the certificate, please forward the syllabus of the course you have taken or are planning to take with your online application. The syllabus will be reviewed for approval.

Below is a list of courses approved to count towards the 15-Credit IDP Certificate. *Space is not guaranteed in any particular course.* All MIDP courses, in addition to all those listed under the International Development Economics Seminars, count towards the Development Elective requirement. Courses vary yearly, depending on faculty availability and curriculum changes. Only approved graduate courses (500 level or above) may be counted towards the certificate. PUBPOL classes with course number 590 may apply to the certificate but are not listed below, as their topics and titles change yearly. **Graduate students interested in pursuing the certificate are responsible for checking the most current available courses on DukeHub.**

Currently enrolled IDP Certificate students may submit syllabi for upcoming semesters via email to Jooyoung Chun at Jooyoung.Chun@duke.edu to be reviewed for approval. **Non-listed courses will only be reviewed during the Shopping Cart Period, registration and drop-add periods of each semester. Please see the Registrar's website for these dates each semester and plan your course load accordingly to ensure you fulfill the requirements for the certificate.**

Also, every term, we share [MIDP Course List on the DCID website](#), so please refer to it for an updated course list. Certain Sanford courses related to International Development may count toward the IDP certificate requirements.

ID ECONOMICS SEMINARS (MINIMUM 3 CREDITS REQUIRED)

We recommend students without an economics background take PUBPOL 701 Economic Foundations for Development (3 credits) which is offered exclusively in the fall. All other Development Economics courses are advanced and require an economics background.
