

CONCURRENT 12-CREDIT GRADUATE CERTIFICATE IN INTERNATIONAL DEVELOPMENT POLICY (IDP)

For those who entered Duke prior to Fall, 2020

The Master of International Development Policy (MIDP) Program offers a 12-Credit Certificate in International Development Policy (IDP) to students who enrolled in full time Duke graduate and professional programs prior to Fall 2020. According to Duke Policy, students who enrolled in Duke prior to Fall 2020 must follow the 12-credit model, rather than the updated 15-credit Certificate launched in Fall 2020. As such, to earn the certificate, the following course requirements must be fulfilled prior to, or in conjunction with graduation from your degree program:

1. Development Management Seminar (3 credits)
2. Development Economics Seminar (3 credits)
3. International Development Elective (6 credits)

Total required for completion of certificate: 12 credits

APPLICATION PROCESS:

- The [12-Credit IDP Certificate Application](#) is required for admission, and applications are accepted on a rolling basis. Applicants will be admitted starting October (for Spring semester) and March (for Fall semester) of each year, during the bookbagging period prior to course registration. *Note:* Students enrolled in the Graduate School must also complete the [Graduate Certificate Program Application](#) as required by their home department, and upload it to the [12-Credit IDP Certificate Application](#).
- You will be notified by MIDP if your application has been approved, and asked to formally accept enrollment before the certificate is added to your record.
- Students may begin taking courses toward completion of the certificate before they are officially enrolled. ***Once the certificate has been added to the academic record it cannot be removed.*** Should the student fail to complete the requirements by the end of their graduation term, the certificate will appear as ‘discontinued’ on their academic record. In addition to the certificate requirements, one must successfully complete their concurrent, primary graduate degree. Failure to earn the primary degree will automatically result in the certificate being ‘discontinued’.
- Students who have completed the requirements without being officially enrolled in the certificate may have it added to their academic record in their final semester of study. Submission of the [IDP Certificate Completion Form](#) is required. Graduate School students must also complete and submit the [Graduate Certificate Program Application](#) as required by their home department. The deadline to submit this completion form and have the IDP Certificate added to a record for Fall graduates is **October 1** of their final semester. The deadline to submit for Spring graduates is **March 1** of their final semester.

APPROVED COURSES:

Below is a list of courses approved to count towards the 12-credit IDP Certificate. *Space is not guaranteed in any particular course.* All MIDP course count towards the International Development Elective requirement, including those listed under the Management and Economics requirement. Courses vary from year to year depending on faculty availability and content priority in each program. PUBPOL classes with course numbers 590 may be applicable to the certificate, but are not listed below as their topics and titles change from year to year. Please check DukeHub for the most current, available

courses. Neighboring universities may be accessed through their own registrar sites. Only approved graduate courses (500 level or above) may be counted towards the certificate.

In order for a class to be counted towards the certificate, the content must focus on international development. If you have questions or are interested in counting a class towards the certificate that is not listed, please upload a current or past syllabi with your online application to be reviewed.

Currently enrolled IDP Certificate students may submit syllabi for upcoming semesters via email to Jooyoung Chun at Jooyoung.Chun@duke.edu to be reviewed for approval. **Non-listed courses will only be reviewed during the bookbagging, registration and drop-add periods of each semester. Please see the Registrar's website for these dates each semester and plan your course load accordingly to ensure you are fulfilling the needed requirements for the certificate.**

A second course from the Development Management or Development Economics category may also serve as an International Development elective. One elective must be fulfilled from the approved elective courses
